- NCC is looking to plant one million trees in the next 5 years and there will be an opportunity to apply for trees in the spring

- the Greater Norwich Local Plan is to be published next month with a consultation on process. The impact for SALW is non-existent however he encouraged consideration as there will be an impact on Norwich & Norfolk.
